POLICY ESSAY – STRUCTURING A RESPONSE:

What is a Policy Essay?

- Persuasive piece of writing
- The goal of a policy essay is to convince the reader of the correctness of your argument
- A policy essay addresses a contentious legal issue and asks you to express you opinion about it – what you think the correct approach may be

• There is no right answer.

Structure: The Thesis Statement

- Usually a single sentence somewhere in the first paragraph which presents your argument to the reader
- The rest of the essay gathers / organises evidence that will persuade the reader of the logic and correctness of your thesis statement
- For example: "I will argue that...because..."

Structure: Argument

- The remainder of the essay is spent supporting your thesis statement with argument / evidence
- Your argument explains why you think what you think (based in legal reasoning / and understanding of how the law operates in practice)
- It identifies counter arguments and why they are not convincing
- CRITICAL ANALYSIS
- Opening sentence examples:
 - "The law in this area is inadequate because it fails to..."
 - "The law has achieved an appropriate balance between the rights of the P and D by..."
- Demonstrating here why you think your thesis statement is correct

Structure: Conclusion

- Your policy essay should include a brief summary of your argument (no more than one paragraph)
- Reiterate your thesis statement and why it is supported by your argument why have you made the conclusion that you have made; what evidence have you drawn on to support you initial thesis statement.

General

- The policy essay should be no more than 2-3 pages
- If you follow the structure, you should have a good guide to what it is that you need to achieve.

MODEL POLICY QUESTION ANSWER
